Notice of Revenue from New Business

Kenedix, Inc. expects to record revenue of about 0.1 billion yen from new business which the Kenedix Group decided to accept on August 28, 2013. Details are as follows.

1. Overview

Fee income is expected for providing asset management and other services to a real estate fund which invests in office buildings and other properties.

2. Outlook

In association with this matter, Kenedix expects to record revenue of about 0.1 billion yen in the third quarter of 2013. There is no change in the 2013 forecast announced on July 17, 2013.
